

## INTRODUCTION TO ONLINE VOTING





#### ONLINE VOTING PROCEDURE

Local 112 is incorporating an online voting procedure requiring our members to register and vote online.

Please follow the process below:

- When online voting commences, you will receive an email notice from "UNIFOR LOCAL 112
  vote@simplyvoting.com "with Voting Deadline, Voting Link, Elector ID and Password. If you
  have not receive an email notice within 24 hours of your online registration, please contact
  admin@unifor112.ca to follow up.
- 2. 2. You <u>MUST</u> vote within the specified voting times for each election to validate your vote, otherwise the Voting Link will inactivate.
- 3. After submitting your vote a confirmation e-mail will be sent to you for your records.
- 4. If you have not received a confirmation e-mail within 24 hours of your voting, please contact <a href="mailto:admin@unifor112.ca">admin@unifor112.ca</a> to follow up.
- 5. You **ONLY** need to register once for online voting. You will automatically be e-mailed of future elections that use online voting.

Your vote selection is secure by Simply Voting and never released.
